## II-Eligibility, Qualification, Experience and Pay Scales:

### 1) REGISTRAR(Regular)

Reader / Associate Professor of Government of Odisha OR State Government aided institutions with at least five years of administrative experience / OR OAS officer with minimum ten years of experience / OR Officers of state level service with minimum ten years of administrative experience.

If a suitable candidate from servicing cadre is not available retired persons with the following requirements shall be considered.

Retired Reader/Associate Professor of Government of Odisha or Retired Reader/ Associate Professor of Government of Odisha aided institutions with minimum five years of administrative experience/ OR Retired OAS officers/ OR Retired officers of state level service with minimum of ten years of administrative experience.

**Age:** Minimum 40 years on the last date of application for persons in service. Retired applicant must be under sixty two years of age on the last date of application. Date of birth entered in the High School Certificate or equivalent issued by board/ council concerned shall be treated as authentic.

**Remuneration:** For persons in service the pay shall be fixed at the last pay drawn. Other benefits such as HRA, TA, medical allowances etc. will be provided to the above post as per rules and norms of Finance Department, Government of Odisha. For retired persons the remuneration shall be fixed at last pay drawn minus pension drawing at present as per O.M.No.5554/F dated 16/12/2012 of the Finance Department of the Government of Odisha or any other rate of remuneration approved by the Finance Department, Government of Odisha at the time of appointment.

**Tenure of retired person:** For a period of three years or till the incumbent attains the age of sixty five, whichever is earlier.

### 2) FINANCE OFFICER (Contractual)

**Eligibility:** Retired officers of OFS/OTAS cadre.

**Age:** Applicant must be under sixty two years of age on the last date of application. Date of birth entered in the High School Certificate or equivalent issued by board/ council concerned shall be treated as authentic.

**Remuneration:** The remuneration shall be fixed as per O.M.No.5554/F dated 16/12/2012 of the Finance Department of the Government of Odisha for contractual appointment or any other rate of remuneration approved by the Finance Department, Government of Odisha at the time of appointment.

**Tenure of retired person:** For a period of one year extendable year wise or till the incumbent attains the age of sixty five.

### 3) ASSISTANT PROFESSOR( ST / Regular)

(Scale of Pay-Rs. 15,600/- - Rs. 39,100/- with AGP of Rs. 6,000/-)

- i. Good academic record with at least 50% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in Mathematics from an Indian University, or an equivalent degree from an accredited foreign university.
- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) for Lecturer / Assistant Professor conducted by the UGC, CSIR or similar tests accredited by the UGC like SLET/SET.

iii. Notwithstanding anything contained in sub-clauses (i) and (ii) the candidates, who are, or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET for recruitment and appointment of Assistant Professor. Further, the award of degrees to candidates registered for the M. Phil. / Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ By laws / Regulations of the institution awarding the degrees and the Ph.D. candidates shall be exempted from the requirement of the minimum eligibility condition of "NET / SLET / SET" for recruitment and appointment of Assistant Professor subject to the fulfilment of the following conditions:

- (a) Ph.D. degree of the candidate awarded in the regular mode only.
  - (b) Evaluation of the Ph.D. thesis must have been done by at least two external examiners.
  - (c) Open Ph.D. viva voce of the candidate had been conducted.
  - (d) Candidate has published two research papers from his / her Ph. D. work out of which at least one must be in a refereed journal.
  - (e) The candidate has made at least two presentations in conferences / seminars based on his / her Ph. D. work.
- (a) to (e) as above are to be certified by the Vice-Chancellor / Pro-Vice-Chancellor / Dean( Academic Affairs) / Dean ( University Instructions), as the case may be.

**For the posts of Assistant Professor the following relaxations are allowed for the purpose of eligibility and for assessing good academic record:**

1. A relaxation of 5% of the marks (from 55% to 50%) may be provided to the Ph. D. degree holders, who have passed their Master's Degree prior to 19 September, 1991. Relevant grade which is regarded as equivalent of 50% wherever the grading system is followed by a recognized university shall also be considered eligible.
2. A relaxation of the minimum marks at the PG level from 55% to 50% for appointment as Assistant Professor may be provided to the candidates who have cleared the JRF Examination conducted by UGC/CSIR only prior to 1989 when the minimum marks required to appear for JRF Examination were 50%.

#### **4) POST DOCTORAL FELLOWS (For one year)**

**Eligibility:**

The candidate should have a Ph. D. Degree in Mathematics from a reputed institute or university. Preference shall be given to candidates in the following areas: Theoretical Computer Science, Number Theory, Complex Analysis, Computational Finance and Algebra. Candidates who have submitted Ph.D. thesis in a reputed institute or university in the above areas and waiting for result shall also be considered.
