Bids complete in all respects will be accepted up to 3.30 PM on 03-03-2018 and the bid will be opened at 4.00 PM on 03-03-2018.

Work: Supply and Installation of Data Points, LAN cabling, other required computer networking materials along with electrical wiring and some repair and maintenance work at Computer Laboratory of IMA, Bhubaneswar. 05	Repair & Maintenance of ceiling.
